Audit Summary

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Okanogan County for the period January 1, 2009, through December 31, 2009.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Billings/receivables
- Cash receipting

- Disbursements/expendituresContracts/agreements
- Procurement (bidding/prevailing wage)
- Telecommunications operations

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

FINANCIAL

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from the District. The firm reported significant deficiencies in internal controls over financial reporting that were also considered material weaknesses in controls related to:

- Proper reporting of unbilled revenue.
- Proper classification, valuation, and allocation of property plant and equipment assets.
- Valuation of impaired investments on the District's accounting records.
- Accounting for work orders for capital projects.
- Proper accounting for and reporting of grant revenues.

Description of the District

ABOUT THE DISTRICT

Public Utility District No. 1 of Okanogan County was established in 1936 by a public vote and began operation in 1945 to provide energy services to Okanogan County. The District provides energy to more than 20,600 residential, commercial, industrial, and irrigation accounts. The District owns and operates an electrical distribution system incorporating both electrical and telecommunication facilities and equipment. With the headquarters in Okanogan, the District also has satellite offices in Oroville, Tonasket, Omak, Brewster and Twisp.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its 92 full-time and five part-time employees. For fiscal year 2009, the District operated on an annual budget of approximately \$43.4 million.
