

Washington Families Clean Energy Credits Program
Income Self-attestation Form
\$200 One-Time Electric Bill Credit



A household may qualify for a one-time \$200 electric utility bill credit from the Washington Families Clean Energy Credit program if it meets the criteria listed below. Use Table 1 below to determine if your household income is less than 150% of the Area Median Income (AMI). ROUND ONE is open now for 80% of AMI. Starting August 1, 2024, ROUND TWO opens to everyone who meets 150% of AMI. Forms must be received by September 5, 2024, and are subject to funding availability.

Household income includes the gross income of all household members: all wages, tips, rental income, public assistance, social security or pensions, income from self-employment, alimony, interest, or any other sources of income defined by the IRS income tax return. **Utility customers are not required to provide documentation of income to qualify for this program. Customers are required to continue to pay their bill until the credit has been applied to the account.**

I am an eligible electric residential customer that receives electricity from Public Utility District No. 1 of Okanogan County. I attest that I meet the eligibility qualifications provisions of the program and declare that my gross household income does not exceed the maximum eligible income for my household size as indicated in the eligible income thresholds in Table 1. (If your household size exceeds 8 persons, please use Table 2 on the reversed side of this form.)

Check One:

- My household income is equal to or less than 80% AMI.
- My household income is equal to or less than 150% AMI.
