

RESOLUTION NO. 1459

**A Resolution Establishing Ethernet & Wireless Rates
on the District's Telecommunication System**

WHEREAS, the District has installed a fiber-optic telecommunications system to provide wholesale telecommunications services to retail providers; and

WHEREAS, the District has established rates for wholesale services charged to retail providers; and

WHEREAS, it is necessary to periodically review the rates to verify the services offered and charges for such services are fair and reasonable; and

WHEREAS, the District has determined it needs to offer rates for various configurations of SONET, Ethernet and Gigabit Ethernet service.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Public Utility District No. 1 of Okanogan County rescinds rates established by Resolution No. 1330 and adopt Ethernet and Wireless Rate Schedule attached hereto dated May 29, 2008.
